**ORDER**

As per the Government Order read 2<sup>nd</sup> above, the benefit of direct purchase in relaxation of para 57(a)(ii) of the old Stores Purchase Manual (para 9.23 of the Revised Stores Purchase Manual 2013) was extended to Kerala Electrical and Allied Engineering Company Ltd. in respect of purchase of Diesel Generator Sets by all Government Departments and Public Sector Undertakings for a period of 5 years exclusively without tender. Subsequently as per Government order read 3<sup>rd</sup> and 4<sup>th</sup> above the benefit was extended for a further period of 5 years and 1 year each up to 2014 respectively. As per the letter read above the Managing Director, Kerala Electrical and Allied Engineering Company Limited (a Government of Kerala undertaking) has requested to extend the above benefit for a further period of 5 years from 21.06.2014.

Government have examined the matter in detail and are pleased to order that the benefit of direct purchase of Diesel Generator Sets manufactured and marketed by Kerala Electrical and Allied Engineering Company Ltd. by all Government Departments and State Public Sector Undertakings without following tender formalities is extended for a further period of one year with effect from 21.06.2014 in relaxation of para 9.23 of revised Stores Purchase Manual 2013 subject to the condition that the cost of stores (Diesel Generator Sets) shall be fixed by the Price Fixation Committee constituted for the purpose from time to time.

Government are also pleased to constitute a Price Fixation Committee comprising the following members, for fixing the price of Diesel Generator Sets manufactured and marketed by Kerala Electrical and Allied Engineering Company Ltd. (KEL) to be supplied by KEL directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies, etc without following tender formalities.

2. Additional Secretary/Joint Secretary to Government, Finance Department, Government Secretariat.
3. Additional Secretary/Joint Secretary to Government, Industries Department, Government Secretariat.
4. Managing Director, Kerala Electrical and Allied Engineering Company Ltd. (KEL), Panampilly Nagar, Kochi
5. Technical Expert, Industries and Commerce Department, Thiruvananthapuram.
6. Additional Director, Economics and Statistics Department, Thiruvananthapuram.
7. Representative from Centre for Management Development, Thiruvananthapuram.
8. Sri. A. Ajithkumar, Cost Accountant.

The Joint Secretary to Government, Stores Purchase Department will be the Chairman and the Managing Director, Kerala Electrical and Allied Engineering Company Ltd. (KEL) will be the convenor of the Price Fixation Committee. The eligible payment towards Sri. A. Ajithkumar, Cost Accountant will be met by Kerala Electrical and Allied Engineering Company Ltd. (KEL) after negotiating a bilateral agreement for the same.

The Convenor (Managing Director, Kerala Electrical and Allied Engineering Company Ltd. (KEL)) of the Price Fixation Committee will take necessary steps for convening the meeting. The convenor will also take action to furnish details/price schedules to the members of the committee to finalize the price of the Diesel Generator Sets manufactured and marketed by Kerala Electrical and Allied Engineering Company Ltd. (KEL) to be supplied to various Government Departments/Public Sector Undertakings/Local Bodies/Autonomous Institutions etc. The convenor will also have to furnish a report to the Stores Purchase Department in the matter, within a short period of time after the meeting, so as to enable Government to issue Orders with the approved price lists.

The Technical Expert from the Industries and Commerce Department, Thiruvananthapuram will inspect the product and furnish report to Government about the quality of the product. The representative from the Economics and Statistics Department will furnish to Government the market price of the product.




