As per Government Orders read as 1st and 2nd above , Government have ordered that 25% of the post of Junior Superintendent will be on higher grade on Rs. 18740-33680.

Accordingly higher grade has been sanctioned up to Smt.M.I. Selma(Serial No. 10), Junior Superintendent vide this office proceedings read as 4th above dated 12.03.2013. As per reference read as 3rd above 14 posts of Senior Superintendents have been newly created in the District Industries Centres and consequently as per reference read 7th above, Smt. Soja Thomas(Serial No. 11), Smt. B. S. Sreelatha(Serial No. 12) and Sri. P.
