As per the reference 1st cited, the Secretary, Kerala Public Service Commission, Thiruvananthapuram have adviced 39 candidates for the appointment of Industries Extension Officers in the scale of pay of Rs. 18740 - 33680 through direct recruitment.

The method for appointment of Industries Extension Officers contemplated in the Special rules for Industries Subordinate Service stipulates that 30% of the cadre strength has to be reported to Kerala Public Service Commission for reporting suitable candidate for appointment as Industries Extension Officers. The vacancies if kept idle would affect the functioning of the department. Hence these posts were filled up by provisional promotion. Now there is no vacancy to accommodate the candidates advised by the Kerala Publicc Service Commission to be appointed as Industries Extension Officer. Hence the junior most Industries Extension Officer provisionally promoted has to be reverted.

Now three direct recruitees to the post of Industries Extension Officers have reported for duty vide reference cited 3rd. Hence the order
