On contemplating on the request of Sri.Abdul Gafoor, it is found genuine. Hence this order.

**ORDER**

In the circumstances stated above, Sri.B.V.Abdul Gafoor is promoted to the post of Senior Superintendent with effect from 10.04.2013, on the day on which his Junior got promotion and joined duty as Senior Superintendent on

condition that the incumbent is eligible for monitory benefit from the date on which he actually officiated in the post of Senior Superintendent i.e.; with effect from 13.02.2014.

The seniority Section in this office is directed to reassign the seniority as provided in the select list in the Notification read 1<sup>st</sup> and place him in between Sri.N.Rajan and Sri.P.D.Gireesh Kumar as Smt.M.M. Ayisha Beevi retired from service on Superannuation.


