As per G.O read 1st & 2nd above, 25% of the post of Senior Superintendents will be granted Higher Grade on Rs.20740-36140 wef 2/2011. The 25% of the total strength of 22 Senior Superintendents of this department is 5. Among the 5 Senior Superintendents, who were awarded Higher Grade vide proceedings read as 5th above, Sri.R Ganesan and Shri.V Sasidharan have been promoted as Administrative Assistants vide G.O read 4th above and Shri.K.C suresh, Senior Superintendent(HG) retired on superannuation on 31.05.2014 from the post of Senior Superintendent(HG).The last Senior Superintendent who was granted Higher Grade is Smt Gangadevi Pillai (SI No.9).Among the next 3 Senior most Senior Superintendents placed in the seniority list of Senior Superintendent read as 6th above, Smt.S Saraswathy,(Serial No:10) and Shri.N Rajan,(Serial No:11) are eligible for Higher Grade promotion. Smt.M.M Aisha Beevi(Serial No:12) retired from service on 30.06.2013.Shri.Abdul Gafoor,Senior Superintendent,District Industries Centre,Kozhikkode is not included in the final seniority list of Senior Superintendents. But, he was included in the final seniority of Junior Superintendent below Shri.N Rajan as read as 7th above. He was excluded from the final seniority list of senior superintendents due to the disciplinary action pending against him at the time of preparation of final seniority list. The disciplinary action has

already been finalized and proposal has been forwarded to Government to include his name in the seniority list below Shri.N Rajan as SI No. 11A . He will be sanctioned Higer Grade soon on receipt of approval from the Government.


