As per the reference 1st cited, the Secretary, Kerala Public Service Commission, Thiruvananthapuram have advised 39 candidates for the appointment of Industries Extension Officers in the scale of pay of Rs. 18740 - 33680 through direct recruitment.

The method for appointment of Industries Extension Officers contemplated in the Special rules for Industries Subordinate Service stipulates that 30% of the cadre strength has to be reported to Kerala Public Service Commission for advising suitable candidate for appointment as Industries Extension Officers. The vacancies if kept idle would affect the functioning of the department. Hence these posts were filled up by provisional promotion. Now there is no vacancy to accomodate the candidates advised by the Kerala Public Service Commission to be appointed as Industries Extension Officer. Hence the junior most Industries Extension Officers provisionally promoted have to be reverted.

Now two direct recruitees to the post of Industries Extension Officer have reported for duty vide reference cited 3rd. Hence the order

ORDER

In this circumstances stated above, the officers mentioned below who had been provisionally promoted to the cadre of Industries Extension Officers are reverted to Senior Co-operative Inspectors in the scale of pay of Rs. 16,180 – 29,180/- w.e.f. the AN of 04.09.2014 and 05.09.2014 FN and posted as such in the offices noted against their name.
