As per Government orders read as 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> above, Government have ordered that the ratio between Senior Co-operative inspector and Junior Co-operative Inspector will be in the ratio of 1:1 and 10% of the total number of Co-operative Inspectors will be placed in the Special Grade on Rs. 16980-31360. The total strength of Junior Co-operative Inspectors and Senior Co-operative inspectors in the Department is 190. Therefore, 19 (nineteen) Senior Co-operative Inspectors are eligible to be promoted as Senior Co-operative Inspector (Special Grade). Out of 19 (nineteen) Senior Co-operative Inspectors (Special Grade) have been promoted as Assistant District Industries Officers as per proceedings 5th cited and 4(four) Senior Co-Operative Inspectors (Special Grade) were retired from service.
