As per Government Order read as 1st above, Government have ordered that the ratio between Senior Co-operative Inspector and Junior Co-operative Inspectors will be in the ratio of 1:1 and 10% of the total number of Co-operative Inspectors will be placed in the Special Grade on Rs. 32,300 - 68,700. The total strength of Co-operative Inspectors in the Department is 190. Therefore, 19 (Nineteen) Senior Co-operative Inspectors are eligible to be promoted as Senior Co-operative Inspectors (Special Grade). Out of 19 (Nineteen) Senior Co-operative Inspectors (Special Grade) one has been promoted as Assistant District Industries Officer as per proceedings 3rd cited and two Senior Co-operative Inspectors (Special Grade) were retired from Service.

As such three (3) senior most Senior Co-operative Inspectors are eligible for promotion to the cadre of Senior Co-operative Inspectors (Special Grade) on Rs. 32,300 - 68,700 on the basis of the Seniority list published as per reference read as 1st above. Hence this order.

ORDER

In the circumstance, sanction is hereby accorded for the promotion of three (3) Senior Co-operative Inspectors as Senior Co-operative Inspectors (Special Grade) in the scale of pay of Rs. 32,300 - 68,700 with effect from the date noted against their name in the list appended.

The post of Senior Co-operative Inspector held by the incumbents in the list appended is hereby designated as "Senior Co-operative Inspector (Special Grade)" in the scale of pay of Rs. 32,300 – 68,700.

The incumbents promoted to the cadre of Senior Co-operative Inspector (Special Grade) will continue to officiate in the same post in the same station. The incumbents are eligible for fixation of pay under Rule 28A, Part I, KSR and arrears of pay and allowances admissible will be drawn and disbursed to them.

Necessary entries regarding the promotion will be made in the Service Book of the incumbents.
