As per the government order read above four Assistant District Industries Officers have been promoted to the post of Assistant Directors and also two Assistant District Industries Officers have entered on long leave and thus six vacancies of Assistant District Industries Officers arose in the department. **ORDER**

The following Industries Extension Officers who are under orders of promotion to the post of Assistant District Industries Officers against the leave vacancies as per this office proceedings read above could not report for duty as Assistant District Industries Officer as the officials who were on leave rejoined duty before the expiry of leave. Hence that order referred second above could not be effected and stands cancelled as far as the following three officers are concerned.
